## PREAMBLE

a) **MARATHA MANDAL'S NATHAJIRAO .G. HALGEKAR INSTITUTE OF DENTAL SCIENCE AND RESEARCH CENTRE** was established in the year 1992. The Institute has established Central Research Laboratory (CRL) in the year 2004, with 10,500 Sq. ft. dedicated space for research. The unit is very well equipped with various diagnostic and laboratory equipment to perform various tests/research associated with molecular biology and immunology in the field of health sciences. CRL is handling projects of various postgraduate students, mainly dental and pharmaceutical sciences across India. Also projects pertaining to Rajiv Gandhi University of Health Sciences (RGUHS) grants of various staff members from the field of dental, medical and pharmacy within the state. This venture has received such an over whelming response from the staff and students of various Dental and Pharmacy Colleges in the state, that the management promptly reciprocated by expanding the department and setting up new protocols for studies involving several Hi-Tech and expensive equipments.

b) **AYURVIDYA PRASARAK MANDAL'S AYURVED MAHAVIDYALAYA SION MUMBAI**, It is a Renowned Maharashtra Government Grant-in-aid institute imparting quality education in sector of Ayurvedic Sciences as well as carrying out research in Ayurvedic Sciences. It is recognized by the National Council of Indian System of Medicine (NCISM) and Maharashtra University of Health Sciences, Nashik. It offers Undergraduate Course Bachelor of Ayurveda Medicine and Surgery (B.A.M.S), Postgraduate (M.D). Ph.D. and various MUHS research workshop, Clinical trials. With the relentless efforts of dedicated and competent faculty, up-dated curriculum, innovative methods of instructions top end infrastructure and study support of management, it has emerged as a center of academic excellence and attracting students from all over India.

## GOALS AND OBJECTIVES:

The parties, subject to the terms of this Memorandum of Understanding and the laws, rules, regulations existing from time to time, agree to promote and develop co-operation and conduct collaborative research in the field of oral microbiology, molecular biology and immunology and cell culture between the two institutions.

Where the **FIRST PARTY** is engaged in academic, teaching and research through quality Pre clinical Toxicological, Pharmacological, Microbiological, in-vitro-cell lines assays, bioanalytical and custom research and developmental services.

Whereas the **SECOND PARTY** is engaged in Academic Teaching and Research in Health Sciences.

The **FIRST PARTY** and **SECOND PARTY** have agreed to take up joint projects in the areas of mutual interest such as in-vitro studies along with training to the students of **SECOND PARTY**.

**Now this deed of MOU is agreed by and between the parties under following terms and conditions.**

## TERMS AND CONDITIONS:

1. **BOTH PARTIES** will share faculty expertise and instrumental facilities to each other as per mutual understanding.





2. Both the parties have mutually agreed upon the usage of required instruments devoid of any charges and by following the norms, terms and conditions led herein, at their premises.

3. The workshop on preclinical studies and training pertaining to the research project undertaken by the interested students and employee of the **SECOND PARTY** shall be conducted by **FIRST PARTY** at the premises of **FIRST PARTY** as per the schedule mutually agreed upon.

4. The visit of interested students of the **SECOND PARTY** to premises of the **FIRST PARTY** shall be taken up as per the schedule mutually agreed upon.

5. Both the parties shall initiate and exchange research facilities and other relevant things required to carry out research projects. The research project interchange and finalization will be done as per mutual understanding of **BOTH PARTIES**.

6. **BOTH PARTIES** may apply for joint research projects to the concerned research organizations. The work load, expenses & profit share in such instances shall be decided upon mutually in writing by both the parties.

7. If the results of the joint projects are liable to attract commercial benefits, then the financial profits shall be shared between the two parties as per the mutually agreed arrangements which shall be made in writing by both the parties.

8. The financial arrangements to cover expenses for the identified activity/s undertaken within the framework of this memorandum of understanding shall be mutually agreed upon by both parties on the case-by-case basis, subject to the availability of funds.

9. Neither of the Parties shall publish any external advertising and publicity relating to this MoU, any co-operation between them, or any of the matters specified in this MoU (including any web-based advertising and publicity) unless the Parties shall both first have agreed in writing the form, content and medium thereof.

10. Either Party may terminate this Memorandum of Understanding at any time with at least 30 days prior written notice to the other Party. The early termination of this Memorandum of Understanding will not affect the completion of any co-operation measures that were agreed under the annual work programs whilst it was in force.

11. Any dispute arising shall be settled through mutual negotiations only without recourse to resolving the dispute by legal means. And for the purpose of settlement of dispute the jurisdiction shall be within the limits of Belagavi.



12. This MOU shall take effect from the date of its signing by **BOTH PARTIES** and shall be valid for the period of 5 (Five) years from the date on which it came into force.

Hence this Memorandum of Understanding executed and signed today that is on Wednesday, 10<sup>TH</sup>, January 2024.
